# **MESSAGE FROM THE PAC GOVERNING COMMITTEE (PGC) LEADERSHIP**

As we look back on the second federal election cycle in which Mississippi Farm Bureau Federation has had an established federal Political Action Committee (PAC), we recognize the positive impact it has made on policy issues affecting our state's farmers and ranchers.

Within two years, our PAC has opened dialogues with key members of Congress and helped our staff develop working relationships with these offices. Your funds were invested wisely in the 2022 election cycle (January 2021 to December 2022), and we are pleased to report the following information on the F.A.R.M. fund:

- Total funds raised: \$246,407
- Total funds spent: \$196,000
  - In-state candidates: \$47,500
  - Out-of-state candidates: \$148,500
- Total in-state candidates supported: 4
- Total out-of-state candidates supported: 71
- Total number of states impacted: 27
- Rank in PAC spending among state Farm Bureaus: 4th
- Percentage of supported candidates winning races: 87%
- House Committee Chairs (2023) supported in 2022: 12 of 20

One of the most important aspects of the F.A.R.M. fund is the ability to develop relationships with key members of Congress for our Mississippi farmers and ranchers.



In September of 2021, the F.A.R.M. fund hosted U.S. Congressman G.T. Thompson (R-PA) for a series of agricultural tours in Mississippi. Thompson is now Chairman of the House Agriculture Committee.



In November of 2021, the F.A.R.M. fund hosted U.S. Congressman Ronny Jackson (R-TX) and U.S. Congressman David Rouzer (R-NC) for farm tours in the Tate County area. Both Jackson and Rouzer are now members of the House Agriculture Committee.



In March of 2022, members of the PAC Governing Committee flew to Washington, D.C. to meet with key congressional members. They participated in the Southern States PAC event, hosted by U.S. Congressman Trent Kelly, and visited with over 25 other members of Congress.



In July of 2022, the F.A.R.M. fund hosted U.S. Senator John Boozman (R-AR), Ranking Member of the U.S. Senate Committee on Agriculture, Forestry, and Nutrition, for a farm bill listening session hosted with U.S. Senator Cindy-Hyde Smith.



In June of 2022, the F.A.R.M. fund hosted U.S. Congresswoman Kat Cammack (R-FL) for farm tours focusing on catfish, rice and cotton. Cammack is a key member of the House Agriculture Committee.



In September of 2022, members of the PAC Governing Committee flew to Washington, D.C., where they met with over 25 key members of Congress.

# **IN-STATE HOUSE CANDIDATES**



### **U.S. CONGRESSMAN TRENT KELLY**

Incumbent First District Congressman Trent Kelly serves as a key member of the House Agriculture Committee. Kelly has been supportive of all MFBF farm policy priorities in Congress. Kelly was awarded with an AFBF Friend of Farm Bureau acknowledgement for his voting record in the 117th Congress. F.A.R.M. fund Investment: \$5,000 in the primary election and \$5,000 in the general election. The F.A.R.M. fund has also supported the Southern States PAC in which Congressman Kelly co-chairs with Congressman Mike Rogers (R-AL) with a \$5,000 investment. Congressman Kelly won his election.



#### **U.S. CONGRESSMAN MICHAEL GUEST**

Incumbent Third District Congressman Michael Guest (R-MS) serves on the House Appropriations Committee. Guest has been very supportive of all MFBF farm policy priorities in Congress. Guest was awarded with an AFBF Friend of Farm Bureau acknowledgement for his voting record in the 117th Congress. F.A.R.M. fund investment: \$5,000 in the primary election, \$5,000 in the run-off election and \$5,000 in the general election. Guest won his election.



#### **U.S. CONGRESSMAN STEVEN PALAZZO**

Incumbent Fourth District Congressman Steven Palazzo (R-MS) served as a key member of the House Committee on Appropriations. Palazzo has been very supportive of all MFBF farm policy priorities in Congress. Palazzo was awarded with an AFBF Friend of Farm Bureau acknowledgement for his voting record in the 117th Congress. F.A.R.M. fund investment: \$5,000 in the primary election and \$5,000 in the run-off election. Palazzo was not successful in his election.



### **MIKE EZELL**

Jackson County Sheriff Mike Ezell defeated Incumbent Fourth District Congressman Steven Palazzo (R-MS) in the Republican primary. MFBF has developed a strong working relationship with Sheriff Ezell. F.A.R.M. fund investment: \$2,500 in the general election and \$5,000 of debt retirement in the primary election. Ezell won in the general election.



### ALABAMA

Katie Britt (R-AL), business leader and former Chief of Staff for Senior U.S. Senator Richard Shelby (R-AL), ran for this seat upon Shelby's retirement in 2022. Alabama Farmers Federation has a long-standing relationship with Britt and actively supported her candidacy. F.A.R.M. fund investment: \$2,500 in the general election. Britt won her election.




### ARIZONA

Arizona businessman Blake Masters (R-AZ) ran as the Republican nominee for United State Senate against incumbent Senator Mark Kelly (D-AZ). Arizona was considered as a toss-up race that could have determined the control of the U.S. Senate in 2023. F.A.R.M.fund investment: \$2,500 in the general election. Masters lost his election.



### ARKANSAS

U.S. Senator John Boozman (R-AR) currently serves as the Ranking Member of the U.S. Senate Agriculture Committee. Boozman has been very helpful in our request for COVID-19 assistance for poultry and numerous other issues. Arkansas Farm Bureau encouraged us to support Senator Boozman. F.A.R.M. fund investment: \$5,000 in the primary election, \$5,000 in the general election and \$5,000 to his leadership PAC. Boozman won his election.



## GEORGIA

Gary Black (R-GA) is an American farmer and politician from Georgia who has been Agriculture Commissioner of Georgia since 2011. He was a candidate for the Republican nomination for U.S. Senate in Georgia in 2022. He is a close friend to U.S. Senator Cindy Hyde-Smith, AFBF President Zippy Duvall and Georgia Farm Bureau President Tom McCall. F.A.R.M. fund investment: \$2,000 in the primary election. Black lost in the primary election.



### **GEORGIA**

Herschel Walker (R-GA) was the Republican candidate for United States Senate in Georgia in 2022. Walker is a former college football player for the University of Georgia and former professional football player for several NFL teams. Walker ran against incumbent U.S. Senator Raphael Warnock in the general election. F.A.R.M. fund investment: \$2,500 in the general election. Walker lost his election.



#### **FLORIDA**

Incumbent U.S. Senator Marco Rubio (R-FL) from Florida was up for re-election in 2022. The Cook Political Report had his race as "Lean Republican". Rubio is a member of the Senate Appropriations Committee and the Senate Foreign Relations. Florida Farm Bureau was very supportive of our contribution for Senator Rubio. F.A.R.M. fund investment: \$2,500 in the general election. Rubio won his election.



### **KANSAS**

Incumbent U.S. Senator Jerry Moran (R-KS) from Kansas was up for re-election in 2022. Moran is a member of the Senate Appropriations, Commerce, and Finance Committees, Veteran Affairs and others. He is the previous chair of the Agriculture Subcommittee and still very involved in that subcommittee. The Kansas Farm Bureau was very supportive of our contribution to Moran. F.A.R.M. fund investment: \$2,500 in the general election. Moran won his election.



### LOUISIANA

Incumbent U.S. Senator John Kennedy (R-LA) from Louisiana was up for re-election in 2022. Kennedy is a member of the Senate Appropriations, Budget, and Judiciary Committees. The Louisiana Farm Bureau is developing a relationship with Senator Kennedy, and were very supportive of our contribution to Kennedy. F.A.R.M. fund investment: \$2,500 in the general election. Kennedy won his election.



### **MISSOURI**

Incumbent U.S. Congresswoman Vicky Hartzler (R-MO) has given up her House seat in the 4th District to run for U.S. Senate upon the retirement of Senator Roy Blount. Missouri Farm Bureau endorsed Hartzler, their first ever endorsement in an open U.S. Senate seat, and was actively seeking assistance to support her campaign. F.A.R.M. fund investment: \$2,500 in the primary election. Hartzler lost her election.



### **NEBRASKA**

Incumbent U.S. Senator Deb Fischer (R-NE) from Nebraska was not in cycle in 2022, however, we felt it appropriate to show our appreciation for her work on beef cattle markets legislation. Fischer is a member of the Senate Ag Committee, Senate Commerce Committee and the Senate Armed Services Committee. MFBF has close relationships with several of her staff members. Nebraska Farm Bureau was very supportive of our contribution for Senator Fischer.

F.A.R.M. fund investment: \$2,500 for her primary election in 2024.




### NEVADA

Former Nevada Attorney General Adam Laxalt (R-NV) ran as the Republican nominee for United State Senate against incumbent Senator Catherine Cortez Masto (D-NV). This Nevada Senate seat was considered a toss-up race that could have determined the control of the U.S. Senate in 2023. F.A.R.M. fund investment: \$2,500 in the general election. Laxalt lost his election.



#### **NORTH DAKOTA**

Incumbent U.S. Senator John Hoeven (R-ND) from North Dakota was up for re-election in 2022. Hoeven is a member of the Senate Ag Committee and Senate Appropriations Committee, where he is the Ranking Member of the Agriculture Subcommittee. U.S. Senator Cindy Hyde-Smith also serves on this subcommittee. MFBF has close relationships with several of his committee staff members. North Dakota was very supportive of our contribution for Senator Hoeven. F.A.R.M. fund investment: \$2,500 in the general election. Hoeven won his election.



### PENNSYLVANIA

Author, presenter, and former cardiothoracic surgeon Mehmet Oz (R-PA) was running as the Republican nominee for United States Senate against former Lt. Governor John Fetterman (D-PA), to fill the vacancy of retiring U.S. Senator Pat Toomey. This Pennsylvania Senate seat was considered a toss-up race that could have determined the control of the U.S. Senate in 2023. F.A.R.M. fund investment: \$2,500 in the general election. Oz lost his election.



#### **SOUTH DAKOTA**

Incumbent U.S. Senator John Thune (R-SD) from South Dakota was up for re-election in 2022. Thune is a member of the Senate Ag, Commerce, and Finance Committees. He also serves as the Senate Republican Whip, the second-highest ranking Senator in the Republican caucus. Thune has been very active on livestock issues and other federal priorities. The South Dakota Farm Bureau was very supportive of our contribution to Thune. F.A.R.M. fund investment: \$2,500 in the general election. Thune won his election.



#### **WISCONSIN**

Incumbent U.S. Senator Ron Johnson (R-WI) from Wisconsin was up for re-election in 2022. Johnson is a member of the Senate Homeland Security Committee, Commerce Committee, Budget, and Foreign Relations. The Wisconsin Farm Bureau officially endorsed Senator Johnson and indicated his strong support for farmers in Wisconsin. Wisconsin Farm Bureau was very supportive of our contribution to Johnson. F.A.R.M. fund investment: \$2,500 in the general election. Johnson won his election.

### ALABAMA

Incumbent U.S. Congressman Barry Moore (R-AL) was a freshman member of the House Agriculture Committee elected in 2020 and serves the second congressional district. Alabama Farmers Federation encouraged us to provide Rep. Moore with campaign support. F.A.R.M. fund investment: \$1,000 in the primary election and \$1,000 in the general election. Moore won his election.



### ALABAMA

Incumbent U.S. Congressman Robert Aderholt (R-AL) was up for election in 2022. MFBF staff has a good relationship with his former agricultural aide, as well as his former chief of staff. Alabama Farmers Federation encouraged us to provide Rep. Aderholt with campaign support. The F.A.R.M.fund supported Aderholt in 2020. F.A.R.M. fund investment: \$1,000 in the primary election and \$1,000 in the general election. Aderholt was his election.



### ALABAMA

Incumbent U.S. Congressman Mike Rogers (R-AL) represents the third congressional district. Rogers is the Chair of the House Armed Services Committee. Alabama Farmers Federation encouraged us to provide Rep. Rogers with campaign support. Congressman Rogers chaired the Southern States Leadership PAC prior to Congressman Trent Kelly taking over. F.A.R.M. fund investment: \$1,000 in the primary election. Rogers won his election.



### ARKANSAS

Incumbent U.S. Congressman Rick Crawford (R-AR) represents the first congressional district. He is a member of the House Agriculture Committee and has been very helpful to the needs of agriculture. Arkansas Farm Bureau does not have a PAC and does not endorse, but encouraged us to provide Rep. Crawford with campaign support. The F.A.R.M. fund supported Crawford in 2020. F.A.R.M. fund investment: \$1,000 in the primary election and \$1,000 in the general election. Crawford won his election.



### ARKANSAS

Incumbent U.S. Congressman Bruce Westerman (R-AR) represents the fourth congressional district. Westerman is a forester and agricultural engineer. He is Chair of the House Natural Resources Committee. We have many staff contacts with Mr. Westerman's office. Arkansas Farm Bureau does not have a PAC and does not endorse, but encouraged us to provide Rep. Westerman with campaign support. F.A.R.M. fund investment: \$1,000 in the primary election. Westerman won his election.




#### ARKANSAS

Incumbent U.S. Congressman French Hill (R-AR) represents the second congressional district, which is all of central Arkansas. We have contacts in his campaign office. Arkansas Farm Bureau does not have a PAC and does not endorse, but encouraged us to provide Rep. Hill with campaign support. F.A.R.M. fund investment: \$1,000 in the primary election. Hill won his election.



### ARKANSAS

Incumbent U.S. Congressman Steve Womack (R-AR) represents the third congressional district of Arkansas. Arkansas Farm Bureau made this request: "Womack has a significant agricultural footprint in his district and has received the Friend of Farm Bureau award in each Congress he has served. He also recently spoke to our annual Officers and Leaders Conference in northwest Arkansas. He and his staff have always been helpful to us on agricultural issues in DC. As a member of the House Appropriations Committee, he also has a significant amount of influence with his colleagues in Congress. I hope the MSFB would strongly consider supporting his re-election campaign if resources would allow." F.A.R.M. fund investment: \$1,000 for the general election.



### CALIFORNIA

Incumbent U.S. Congressman Jim Costa (D-CA) represents the sixteenth congressional district. Costa is the second-highest ranking Democrat on the House Agriculture Committee behind Rep. David Scott. He has a particular interest in dairy issues. California Farm Bureau was supportive of our contribution to Costa. F.A.R.M. fund investment: \$1,000 in the primary election. Costa won his election.



### CALIFORNIA

Incumbent U.S. Congressman Doug LaMalfa (R-CA) represents the first congressional district of California. LaMalfa is a rice farmer and serves on the House Agriculture Committee, where he is the chair of the Forestry Subcommittee. He is also a member of the House Transportation and Infrastructure Committee. California Farm Bureau was supportive of our contribution to LaMalfa. F.A.R.M. fund investment: \$1,000 in the primary election. LaMalfa won his election.



### **CALIFORNIA**

Incumbent U.S. Congressman Jimmy Panetta (D-CA) represents the twentieth congressional district of California. Panetta serves on the House Agriculture Committee. California Farm Bureau was supportive of our contribution to Panetta. F.A.R.M. fund investment: \$1,000 in the primary election. Panetta won his election.



### **FLORIDA**

Incumbent U.S. Congresswoman Kat Cammack (R-FL) represents the eighth congressional district. She was elected in 2020, after the retirement of Congressman Ted Yoho. She is a member of the House Agriculture Committee and has been very helpful to the needs of agriculture. Florida Farm Bureau was supportive of our contribution to Congresswoman Cammack, who toured Mississippi on June 27-28, 2022. F.A.R.M. fund investment: \$5,000 in the primary election and \$2,500 to her leadership PAC. Cammack won her election.



### FLORIDA

Incumbent U.S. Congressman John Rutherford (R-FL) represents the eighth congressional district. He is a member of the House Appropriations Committee and has been very helpful to the needs of agriculture, according to the Florida Farm Bureau. MFBF has contacts in Mr. Rutherford's office. Florida Farm Bureau was supportive of our contribution to Rutherford. F.A.R.M. fund investment: \$1,000 in the primary election and \$1,000 in the general election. Rutherford won his election.



### **FLORIDA**

Incumbent U.S. Congressman Greg Steube (R-FL) represents the seventeenth congressional district. He is a member of the House Judiciary Committee and has been very helpful to the needs of agriculture, according to the Florida Farm Bureau. MFBF has contacts in Mr. Steube's office. Florida Farm Bureau was supportive of our contribution to Steube. F.A.R.M. fund investment: \$1,000 in the primary election. Steube won his election.



#### **FLORIDA**

Incumbent U.S. Congressman Neal Dunn (R-FL) represents the second congressional district. He is a member of the House Energy and Commerce Committee and has been very helpful to the needs of agriculture, according to the Florida Farm Bureau. MFBF has strong contacts in Mr. Dunn's office. Florida Farm Bureau was supportive of our contribution to Dunn. F.A.R.M. fund investment: \$1,000 in the primary election. Dunn won his election.




### **GEORGIA**

Incumbent U.S. Congressman Sanford Bishop (D-GA) represents the second congressional district and is the Ranking Member of the House Appropriations Subcommittee on Agriculture. Georgia Farm Bureau was supportive of our contribution to Rep. Bishop. American Farm Bureau Federation recently honored Bishop with its Golden Plow Award on the House side for 2020. The F.A.R.M. fund supported Bishop in 2020. F.A.R.M. fund investment: \$2,500 in the primary election and \$2,500 for the general election. Bishop won his election.



### GEORGIA

Incumbent U.S. Congressman Rick Allen (R-GA) represents the twelfth congressional district. AFBF President Zippy Duvall is very close to Congressman Allen, and Georgia Farm Bureau was supportive of our contribution to him. F.A.R.M. fund investment: \$1,000 in the primary election. Allen won his election.



### **GEORGIA**

Incumbent Democratic U.S. Congressman David Scott (D-GA) was in a close race with Republican challenger Becky Hites. Scott is the second-highest ranking member of the Democratic party on the House Agriculture Committee, and has been very helpful to the needs of Georgia agriculture. Scott was awarded with an AFBF Friend of Farm Bureau acknowledgement for his voting record in the 117th Congress. Georgia Farm Bureau does not have a PAC, but highly encouraged our contribution to Congressman Scott. F.A.R.M. fund investment: \$2,500 in the general election. Scott won his election.



### **GEORGIA**

Incumbent U.S. Congressman Austin Scott (R-GA) represents the eighth congressional district. He is a member of the House Agriculture Committee. Scott is also the Chair of the General Farm Commodities and Risk Management Subcommittee of the House Agriculture Committee. Georgia Farm Bureau was supportive of our contribution to Congressman Scott. The F.A.R.M. fund supported Scott in 2020. F.A.R.M. fund investment: \$1,000 in the primary election. Scott won his election.



#### **GEORGIA**

Incumbent U.S. Congressman Buddy Carter (R-GA) represents the first congressional district. He is a member of the House Budget Committee, as well as the House Energy and Commerce Committee. Carter was one of several House Budget Committee members running for the position of Chair of the House Budget Committee. Georgia Farm Bureau was supportive of our contribution to Congressman Carter. F.A.R.M. fund investment: \$1,000 in the general election. Carter won his election.



### GEORGIA

Incumbent U.S. Congressman Drew Ferguson (R-GA) represents the third congressional district. He is a member of the House Ways and Means Committee. Ferguson was one of several members running for the postition of House Majority Whip. The Whip controls a large amount of authority over the House Rules Committee, which dictates which amendments are allowed to be offered by members on legislation. Georgia Farm Bureau was supportive of our contribution to Congressman Ferguson. F.A.R.M. fund investment: \$2,500 in the general election. Ferguson won his election.



### **ILLINOIS**

Incumbent U.S. Congressman Rodney Davis (R-IL) represents the thirteenth congressional district of Illinois. He was a member of the House Agriculture Committee and a member of the House Transportation and Infrastructure Committee. Illinois Farm Bureau was supportive of our contribution to Davis. F.A.R.M. fund investmen: \$1,000 in the primary. Davis lost his election.



### **ILLINOIS**

Incumbent U.S. Congresswoman Mary Miller (R-IL) represents the fifteenth congressional district of Illinois. She is a member of the House Agriculture Committee and a member of the House Education and Labor Committee. Illinois Farm Bureau voted to endorse Miller in the general election and was supportive of our contribution to her. F.A.R.M. fund investment: \$1,000 for the general election. Miller won her election.



### INDIANA

Incumbent U.S. Congressman Jim Baird (R-IN) represents the fourth congressional district of Indiana. He is a member of the House Agriculture Committee, where he is Chair of the Biotechnology, Horticulture, and Research Subcommittee. Indiana Farm Bureau was supportive of our contribution to Baird. F.A.R.M. fund investment: \$1,000 in the general election. Baird won his election.



#### IOWA

Incumbent U.S. Congressman Randy Feenstra (R-IA) represents the fourth congressional district of Iowa. He is a member of the House Agriculture Committee. Iowa Farm Bureau was supportive of our contribution to Congressman Feenstra. F.A.R.M. fund investment: \$1,000 in the general. Feenstra won his election.



## **KENTUCKY**

Incumbent U.S. Congressman James Comer (R-KY) represents the first congressional district and was elected to Congress in 2016. Comer was the Secretary of Agriculture in Kentucky from 2012 to 2016, and he is is now Chair of the House Oversight Committee. Kentucky Farm Bureau (KYFB) was supportive of our contribution to Congressman Comer. F.A.R.M. fund investment: \$1,000 in the primary election. Comer won his election.



### **KENTUCKY**

Incumbent U.S. Congressman Harold Rogers (R-KY) represents the fifth congressional district and was elected to Congress in 1981. He's considered the dean of the Kentucky House delegation. Rogers is the second-highest ranking Republican on the House Appropriations Committee. Kentucky Farm Bureau was supportive of our contribution to Congressman Rogers. F.A.R.M. fund investment: \$1,000 in the primary election. Rogers won his election.



### LOUISIANA

Incumbent U.S. Congresswoman Julia Letlow (R-LA) represents the fifth congressional district. She is a member of the House Appropriations Committee and sits on the Agriculture Subcommittee. Louisiana Farm Bureau was supportive of our contribution to Congresswoman Letlow. The F.A.R.M. fund supported Letlow in 2020. F.A.R.M. fund investment: \$2,000 in the primary election and \$1,000 in the general election. Letlow won her election.



# LOUISIANA

Incumbent U.S. Congressman Clay Higgins (R-LA) represents the third congressional district. Higgins is not a member of the House Agriculture Committee, but has been very helpful to the needs of agriculture, according to Louisiana Farm Bureau. They were supportive of our contribution to Congressman Higgins. F.A.R.M. fund investment: \$1,000 in the primary election. Higgins won his election.



### LOUISIANA

Incumbent U.S. Congressman Steve Scalise (R-LA) represents the first congressional district. Scalise now serves as Majority Leader in the House of Representatives. Louisiana Farm Bureau was supportive of our contribution to Congressman Scalise. F.A.R.M. fund investment: \$2,000 in the primary election. Scalise won his election.



LOUISIANA Incumbent U.S. Congressman Mike Johnson (R-LA) represents the fourth congressional district. Johnson served as Vice Chair of the House Republican Conference and is a member of the House Judiciary Committee. Louisiana Farm Bureau was supportive of our contribution to Congressman Johnson. F.A.R.M. fund investment: \$1,000 in the primary election. Johnson won his election.



# MARYLAND

Incumbent U.S. Congressman Andy Harris (R-MD) represents the first congressional district of Maryland. Harris currently serves as Chair of the House Appropriations Subcommittee on Agriculture. Maryland Farm Bureau was supportive of our contribution to Congressman Harris. F.A.R.M. fund investment: \$1,000 in the general election. Harris won his election.



### **MISSOURI**

Incumbent U.S. Congressman Jason Smith (R-GA) represents the eighth congressional district. He is currently the Chair of the House Ways and Means Committee. Missouri Farm Bureau was supportive of our contribution to Congressman Smith. F.A.R.M. fund investment: \$1,000 in the general election. Smith won his election.



### **MISSOURI**

Incumbent U.S. Congresswoman Ann Wagner (R-MO) represents the second congressional district. Missouri Farm Bureau was supportive of our contribution to Congresswoman Wagner. The F.A.R.M. fund supported Wagner in 2020. F.A.R.M. fund investment: \$1,000 in the primary election and \$1,000 in the general election. Wagner won her election.



#### MISSOURI

Incumbent U.S. Congressman Sam Graves (R-MO) represents the sixth congressional district. Graves serves as Chair of the House Transportation & Infrastructure Committee and is considered the dean of Missouri House Delegation. Missouri Farm Bureau was supportive of our contribution to Congressman Graves. F.A.R.M. fund investment: \$1,000 in the primary election. Graves won his election.



#### **MISSOURI**

Missouri farmer and Farm Bureau member, Kalena Bruce, ran in the Republican primary in House District 4. Bruce is a 5th generation farmer and CPA who lives in Stockton, MO. She served on the Missouri Young Farmers & Ranchers Committee, served as the American Farm Bureau Federation Young Farmers & Ranchers Committee chair, and as the president of her local county Farm Bureau board. Missouri Farm Bureau endorsed Bruce and was actively seeking assistance to support her. F.A.R.M. fund investment: \$2,000 in the primary election. Bruce lost her election in the primary.



### **NEBRASKA**

Incumbent U.S. Congressman Don Bacon (R-NE) represents the second congressional district. Bacon is a member of the House Agriculture Committee. The F.A.R.M. fund supported Bacon in 2020. Nebraska Farm Bureau was supportive of our contribution to Congressman Bacon. F.A.R.M. fund investment: \$1,000 in the primary election and \$1,000 in the general election. Bacon won his election.



### NEBRASKA

Freshman U.S. Congressman Mike Flood (R-NE) represents the first congressional district. He's held this office since the resignation of Rep. Jeff Fortenberry in July of 2022. Nebraska Farm Bureau requested support for Flood. F.A.R.M. fund investment: \$1,000 in the general election. Flood won his election.

### **NORTH CAROLINA**

Incumbent U.S. Congressman Richard Hudson (R-NC) represents the eighth congressional district. We have strong relationships with staff in Hudson's office. North Carolina Farm Bureau was supportive of our contribution to Congressman Hudson. F.A.R.M. fund investment: \$1,000 in the primary election. Hudson won his election.



### NORTH CAROLINA

U.S. Congressman David Rouzer (R-NC) is a Republican representing North Carolina's seventh congressional district. He is a member of the House Agriculture Committee and has been very helpful to the sweet potato industry. F.A.R.M. fund investment: \$1,500 in the primary election and \$1,000 in the general election. Rouzer won his election.



### OHIO

Steve Chabot (R-OH) is a Republican representing Ohio's first congressional district. Chabot serves on the House Foreign Affairs and House Judiciary Committees. Chabot's race was one of the most competitive in the country. Ohio Farm Bureau has a great relationship with Chabot and was very supportive of our support. F.A.R.M. fund investment: \$1,000 for the general election. Chabot lost his election.



## **OKLAHOMA**

Incumbent U.S. Congressman Frank Lucas (R-OK) represents the third congressional district. He is Chair of the House Committee on Science, Space, and Technology. He is a former chair of the House Agriculture Committee and has returned to the Committee for the 2023 Farm Bill. Oklahoma Farm Bureau was supportive of our contribution to Congressman Lucas. F.A.R.M. fund investment: \$1,000.00 in the primary election and \$1,000 in the general election. Lucas won his election



### **OKLAHOMA**

Incumbent U.S. Congressman Tom Cole (R-OK) represents the fourth congressional district. Cole is Chair of the House Rules Committee. Oklahoma Farm Bureau was supportive of our contribution to Congressman Cole. F.A.R.M. fund investment: \$1,000.00 in the primary election. Cole won his election.



#### PENNSYLVANIA

Incumbent U.S. Congressman G.T. Thompson (R-PA) is Chair of the House Agriculture Committee and has been very helpful to the needs of agriculture. Pennsylvania Farm Bureau does not have a PAC, but encouraged our support of Rep. Thompson through campaign assistance. Rep. Thompson was awarded with an AFBF Friend of Farm Bureau acknowledgement for his voting record in the 117th Congress. In September of 2021, MFBF had the opportunity to host Congressman Thompson in Mississippi for 3 days. F.A.R.M. fund investment: \$5,000 in the primary election, \$5,000 in the general election and \$2,500 for his leadership PAC. Thompson won his election.



### **SOUTH DAKOTA**

Incumbent U.S. Congressman Dusty Johnson (R-SD) represents the at-large district of South Dakota. Johnson is a member of the House Agriculture Committee and has been very active on cattle and livestock-related policy. He is also Chair of the Commodity Markets, Digital Assets, and Rural Development Subcommittee of the House Agriculture Committee. South Dakota Farm Bureau was supportive of our contribution to Congressman Johnson. F.A.R.M. fund investment: \$1,000 in the general election. Johnson won his election.



### TENNESSEE

Incumbent U.S. Congressman Scott DesJarlais (R-TN) represents the fourth congressional district of Tennessee. DesJarlais was a member of the House Agriculture Committee in the 117th Congress. Tennessee Farm Bureau was supportive of our contribution to Congressman DesJarlais. F.A.R.M. fund investment: \$1,000 in the primary election. DesJarlais won his election.

### **TENNESSEE**

Incumbent U.S. Congressman David Kustoff (R-TN) represents the eighth congressional district. Tennessee Farm Bureau was supportive of our contribution to Congressman Kustoff. F.A.R.M. fund investment: \$1,000 in the primary election. Kustoff won his election.



### TEXAS

Incumbent U.S. Congresswoman Kay Granger (R-TX) represents the twelfth congressional district. She is Chair of the House Appropriations Committee and has been very helpful to the needs of agriculture. The F.A.R.M. fund supported her in 2020. Texas Farm Bureau was supportive of our contribution to Granger. F.A.R.M. fund investment: \$1,000 in the primary election. Granger won her election.



#### TEXAS

Incumbent U.S. Congressman Vicente Gonzalez (D-TX)) represents the fifteenth congressional district of Texas. The F.A.R.M. fund supported him in 2020. Texas Farm Bureau was supportive of our contribution to Congressman Gonzalez. F.A.R.M. fund investment: \$1,000 in the primary election and \$1,000 in the general election.
